These have been taken from books and journals read, as well as noted down from conferences and meetings attended. Entries were made into little yearly diaries. Over the last two decades, I have used these as a good source of my material for the numerous surgical quiz shows I have conducted for the relevant audiences (mainly surgical postgraduates and residents of the MS and DNB general surgical streams) at City, State, and National levels. Also, as part of my Quiz shows are numerous 'filler slides' of surgical aphorisms, myths, and humour, making it into a whole session of 'Quizotainment'. I have now attempted to put together all these surgical and medical facts into some sort of order and grouping to help easy reference and retrieval. I have included surgical aphorisms and humour, too, to offer an angle of fun while assimilating the fact, hence the title Fact and Fun in Surgery. It is important to note that the vast majority of the facts and quotes are NOT my own, and for many of them, I have not been able to trace their origin. I immensely thank all these unmentioned contributors for having shared their facts in the surgical literature or discussions. I have listed the broad references of the books in which the majority of these facts and fun quips are mentioned, but the list is not complete. It is also relevant to note that these fact listings are not exhaustive, nor do they cover all disciplines of medicine. They are predominantly surgical, with a few from the grey areas between surgery and other specialities. By compiling this book of surgical and medical facts, I do hope to fill a small void in surgical learning at the student level. I have always maintained that a person with no sense of humour has no sense at all and so used the aphorism, the pun, and the light-hearted wit, judiciously, to cool down the burden of memorisation, and later, to help in the recall. The combination of fact with fun definitely helps retentiveness and recollection of the fact. The book will, perhaps, help teachers too, in their preparations for teaching sessions.

Increased concern for patient safety has put the issue at the top of the agenda of practitioners, hospitals, and even governments. The risks to patients are many and diverse, and the complexity of the healthcare system that delivers them is huge. Yet the discourse is often oversimplified and underdeveloped. Written from a scientific, human factors perspective, *Patient Safety: A Human Factors Approach* delineates a method that can enlighten and clarify this discourse as well as put us on a better path to correcting the issues. People often think, understandably, that safety lies mainly in the hands through which care ultimately flows to the patient—those who are closest to the patient, whose decisions can mean the difference between life and death, between health and morbidity. The human factors approach refuses to lay the responsibility for safety and risk solely at the feet of people at the sharp end. That is where we should intervene to make things safer, to tighten practice, to focus attention, to remind people to be careful, to impose rules and guidelines. The book defines an approach that looks relentlessly for sources of safety and risk everywhere in the system—the designs of devices; the teamwork and coordination between different practitioners; their communication across hierarchical and gender boundaries; the cognitive processes of individuals; the organization that surrounds, constrains, and empowers them; the economic and human resources offered; the technology available; the political landscape; and even the culture of the place. The breadth of the human factors approach is itself testimony to the realization that there are no easy answers or silver bullets for resolving the issues in patient safety. A user-friendly introduction to the approach, this book takes the complexity of health care seriously and doesn't oversimplify the problem. It demonstrates what the approach does do, that is offer the substance and guidance to consider the issues in all their nuance and complexity.

This manual explains how to make the right decisions on the timing and selection of investigations and surgical procedures in emergency and urgent surgical settings and describes the most widely used procedures step by step with the aid of high-quality illustrations. Familiarity of the surgeon with the basic physical principles of the various devices employed in this technology-dependent form of surgery ensures safe use, prolonged equipment life and smooth execution of surgical endoscopic interventions. Equally important is the acquisition of the basic skills of endoscopic surgical practice, since these differ in several important respects from those of conventional open surgery. Mastery of the craft of endoscopic surgery requires a determined commitment to training and is no easy option, but once acquired is rewarded by the extreme professional satisfaction experienced when one witnesses the remarkable progress of patients who have undergone major surgical interventions, with minimal discomfort and pain, lower morbidity and rapid return to gainful employment.
