I accept the resurrection of Jesus not as an invention of the community of disciples, but as an historical event. When a leading orthodox Jew makes such a declaration, its significance can hardly be overstated. Pinchas Lapide is a rabbi and theologian who has specialized in the study of the New Testament. In this book he convincingly shows that an irreducible minimum of experience underlies the New Testament account of the resurrection, however much of the details of the narrative may be open to objection. He maintains that life after death is part of the Jewish faith experience, and that it is Jesus' messiahship, not his resurrection, which marks the division between Christianity and Judaism. Dr. Lapide quotes Moses Maimonides, the greatest Jewish thinker, in his support: All these matters which refer to Jesus of Nazareth...only served to make the way free for the King Messiah and to prepare the whole world for the worship of God with a united heart. Hundreds of American soldiers were already dead. Battlefields in Massachusetts and New York were soaked in the blood of American patriots. And 11-year-old Nathaniel Knox was in the midst of it all, trapped in a swamp and fighting for his life. The air was thick with smoke and gunpowder. Bleeding soldiers screamed in agony. Through the trees, Nate saw the line of British redcoat soldiers - at least 100 men. Their blood-colored uniforms seemed to glow in the smoky haze. Gunfire blasted all around him. Nate knelt behind a rock, gripping his gun with shaking hands. The American Revolution had started as a glorious struggle for freedom. America was determined to tear itself away from England, out of the grips of King George III. The thirteen American colonies would become a brand new country: The United States of America! But King George was like a snake with America gripped in his fangs - and he didn't want to let go. So now it was war - brutal, bloody war.

The Grammar of the English Tense System forms the first volume of a four-volume set, The Grammar of the English Verb Phrase. The other volumes, to appear over the next few years, will deal with mood and modality, aspect and voice. The book aims to provide a grammar of tense which can be used both as an advanced reference grammar (for example by MA-level or postgraduate students of English or linguistics) and as a scientific study which can act as a basis for and stimulus to further research. It provides not only a wealth of data but also a unique framework for the study of the English tense system, which achieves great predictive and explanatory power on the basis of a limited number of relatively simple rules. The framework provided allows for an analysis of the semantics of individual tenses which reflects the role of tenses not only in locating situations in time relative to speech time but also in relating situations in time relative to one another to form temporally coherent discourse. Attention is paid to the relations between tenses. On the one hand, we can identify sets of tenses linked to particular temporal areas such as the past or the future. These sets of tenses provide for the expression of a system of temporal relations in a stretch of discourse in which all the situations are located within the same temporal area. On the other hand, there are many contexts in which speakers might in theory choose between two or more tenses to locate a situation (e.g., when we choose between the past tense and the present perfect to locate a situation before speech time), and the book examines the difference that a choice of one or the other tense may make within a discourse context. The book moves from a detailed exploration of the meaning and use of individual tenses to a thorough analysis of the way in which tenses can be seen to function together as sets, and finally to a detailed examination of tenses in, and tenses interacting with, temporal adverbials. Original data is used frequently throughout the book to illustrate the theory discussed.

Throughout his various stages, Dylan's work reveals an affinity with the Zen worldview, where enlightenment can be attained through meditation, self-contemplation and intuition rather than through faith and devotion.
